4. The Practice:

- ✓ Psychometric tests are standardized and scientifically developed tools for measuring an individual's psychological attributes such as aptitude, personality, values and abilities.

4. The Practice:

- ✓ The psychometric test is conducted for the MBA program students in the first semester.
- ✓ The psychometric test of students is conducted online.
- ✓ Before conducting psychometric tests, an orientation program is performed for the students to make them understand the objectives and nature of the test.
- ✓ The schedule of the psychometric test is displayed in the form of a notice. The students appear for the psychometric test accordingly.
- ✓ After the psychometric test, an exhaustive examination report is communicated to the student, counsellor and mentor faculty member.
- ✓ The psychometric test assesses the aptitude of the students' w.r.t. critical abilities cognitive ability, numerical ability, reasoning ability, verbal ability, rapid evaluation ability and spatial ability.
- ✓ The psychometric test assesses the personality of the students' w.r.t. following dimensions extroversion, introversion, sensing, intuition, thinking, feeling, judging and perceiving.
- ✓ After the psychometric test, counselling based on the psychometric test report is provided to the students by professional counsellors.
- ✓ The counselling schedule is displayed in the form of a notice. The students attend the counselling sessions accordingly.
- ✓ The Institute has tied up with professional agencies for psychometric tests and counselling.

5. Evidence of Success:

- ✓ After the psychometric test, a comprehensive report is given to the students, counsellor, and mentor faculty members.
- ✓ The psychometric test report contains a complete profile of the students w.r.t. aptitude and personality.
- ✓ The psychometric test report makes the students understand their personality and recognize their strengths and weaknesses.
- ✓ The psychometric test and counselling act as a fundamental step to realizing self-potential. Self-awareness leads to self-development.

- ✓ One faculty member is appointed as coordinator for the examination and counselling.
- ✓ Professional counsellors are required for counselling, which a professional agency provides.
- ✓ The trust provides guidelines and policies regarding professional charges to be paid to the approved agency.

7. Other Information:

The practice of Psychometric Tests and Counseling results in self-awareness among students and guides them towards personality development.
